The yield is doubled to 40% if the index quotes 20% or more above the starting value at the end of the term. ### **FUNCTIONALITY**

- At the initial valuation date the starting value (closing price of the STOXX® Europe ESG Leaders Select 30 index) is determined.
- At the final valuation date the closing price of the index is compared to the starting value and one of the following scenarios will apply:

## SCENARIO 1: Index UNCHANGED or ABOVE the starting value

# A) Index +20% or more $\rightarrow$ 40% yield + 100% nominal value

If the closing price of the index quotes at 20% or more above the starting value at the final valuation date, redemption at the maturity date is effected at 140% of the nominal value. This is equivalent to EUR 1,400 per EUR 1,000 nominal value and at the same time represents the maximum payout.

B) Index between +0 and +20% → 20% yield + 100% nominal value




