This certificate will be redeemed in December 2028 at 116% if the EURO STOXX 50® and the S&P 500® always quoted above their respective barrier of 49% of their starting value throughout the term. If the barrier is violated, the certificate is redeemed according to the performance of the worse index. In this case, a significant capital loss is possible.

How the certificate works

At the beginning of the term the starting value of the underlying is fixed and the barrier is calculated on this basis. During the observation period, the underlying price is compared with the barrier.

At the end of the term there are two options:

- 1. Barrier was never touched or undercut
The certificate is redeemed at 116%.
- 2. Barrier was touched or undercut at least once
The certificate is redeemed according to the performance of the index (final value compared to the initial value). The maximum redemption remains limited to 116% of the nominal amount.

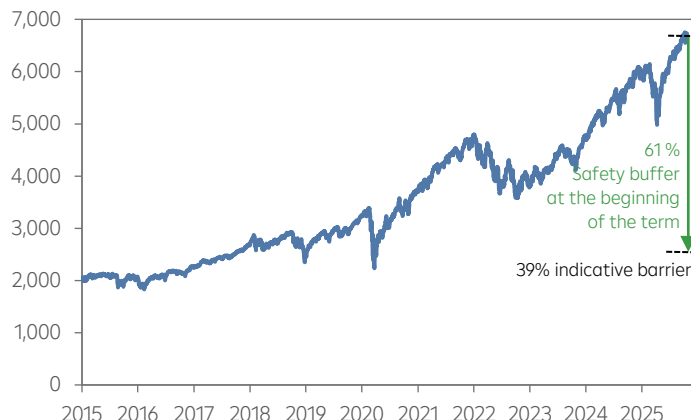
Development in the past
