The Securityholders are hereby informed that the European Commission announced on 27 January 2026 that with the release of the January 2026 data the harmonised index of consumer prices will adopt the European Classification of Individual Consumption According to Purpose, version 2 (ECOICOP ver. 2). Eurostat has consequently restructured their data tables and the description of the consumer price index of the Securities has been updated as of 25 February 2026 to "HICP ECOICOP ver.2 (2015=100) monthly data - Overall index excluding tobacco Euro area".
